**Agenda No.1: Approval of decisions taken in the previous meeting dated 03<sup>rd</sup> February 2022.**

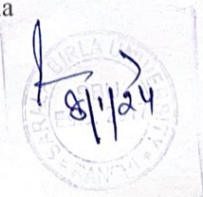
**Decision:-** The members of the Governing Body approved all the decisions taken in the previous meeting dated 03<sup>rd</sup> February 2022.



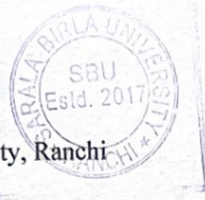
