

The distinctive characteristics of the faculties of SBU have always been intellectual brilliance, spiritual vibrancy, and social relevance. The curriculum also includes a work component that enables students to increase their knowledge, get experience, and develop their skills and values to realise their full potential and find employment globally. To reflect current trends in the field and to make use of the newest structures, the syllabus for every course is regularly revised.

Collaboration with foreign Universities

SBU has made significant developments in international collaboration and global partnership with some prestigious universities of the world like the University of Minnesota, Berkeley-University of California, etc to ensure international exposure and enrich the academic and professional development of the students.

Achievement of University during 2022-23:

Life @ SBU:

At Sarala Birla University, we believe that the quality of campus upkeep reflects the quality of education. In keeping with its strong pro-green tradition, no effort is spared in ensuring that the sprawling 55 acres of campus is kept clean, green, and becoming of our lofty educational standards.

At SBU, we have a strict no-tolerance policy towards littering, chewing tobacco, smoking, drinking, and unnecessary usage of plastic and paper.

Central Library:

The University's library contains a substantial and varied collection of books, mostly in the areas of Management, Information Technology, Business, Engineering, Yoga, Language, and Nursing, as well as access to the internet and Wi-Fi. A strong library is the foundation of any educational establishment. In light of this, we have 13000 volumes and 21 journal subscriptions, and plagiarism detection software like Turnitin.



Laboratories and Workshops: SBU believes in imparting strong practical exposure to its students. Modern laboratories, workshops, and studios are an integral part of the various departments of the University. Each department maintains its specialized labs and workshops, equipped with modern equipment's of industry standards. Labs at SBU can compete with any Institution of national repute. With the financial support of SBU management and the expertise of the concerned faculty and outside experts, we established several new labs in ECE, EEE, ME, CE, CSE and Yoga last year.

Seminar Halls:

Sarala Birla University provides audio-visual equipped Seminar Halls. For large gatherings, the B. K. Birla Auditorium is being used. It is fully air-conditioned has a capacity of 800+ audience and is equipped with all the latest technological gadgets. Shortly we are going to inaugurate the "G.D Birla Auditorium" on the campus with 400 sitting capacities for our students.

Hostels:

All courses offer accommodation for male and female students, depending on space, which is permitted in the dorm based on bed availability. With a total of 170 beds for girls and 175 beds for boys, we have secure residential facilities for both boys and girls. To extent the facilities we are going the inaugurate Boys' hostels and girls' hostels of 658 bed capacities as soon as possible.

In addition to having a constant supply of normal water, purified drinking water, and electricity, the hostels also have their own housekeeping staff. With a team of wardens (both male and female) residing on the hostel grounds, they have 24-hour security.

Cafeteria:

SBU features a reputable cafeteria and restaurant on campus called "Die Mensa" and its extension outlet of 500 capacities serves a variety of cuisines to the students and staff. The university's students and employees can meet their needs through the extremely hygienic culinary facilities that are offered.

Transport:

The university operates a fleet of buses for the convenience of its students and staff due to the high number of day scholars. SBU operates 15 buses in total, serving all routes throughout Ranchi while upholding punctuality and safety.

Significant Accounting Policies and Notes on Accounts for the year ended 31st March, 2023

A. SIGNIFICANT ACCOUNTING POLICIES

1 Accounting Concepts

- i The accounts are prepared on the historical cost basis and on accrual basis of accounting as a going concern and in accordance with the generally accepted accounting principles.
- ii Accounting policies not specifically referred to otherwise are consistent and in consonance with generally accepted accounting principles.

2 Recognition of Income & Expenditure

Fees from students comprising of Tuition Fees. Session Fee. Development fees. Examination Fee . ICT Fees is recognised on semester wise basis. While other Fees being Application fees. Bus Fee, Late Fee. Fines. Admission fee, Hostel Fee. Re-registration fee are recognised on cash basis

Interest income is recognised on time proportion basis.

Expenses are accounted for on accrual basis.

Subsidy from government, if any, are accounted for on receipt basis.

3 Inventories

Inventories . being consumable in nature are valued at cost on FIFO Basis.

4 Property, Plant & Equipment

Property, Plant and Equipment are stated at cost less accumulated depreciation.

Cost includes all expenses attributable to bringing the assets to its intended use. Projects under Commissioning and other Capital Works-in-Progress are carried at cost, comprising direct cost and related incidental expenses including attributable borrowing costs.

5 Depreciation

Depreciation is provided in the books on Written Down Value method at rates prescribed in the Income Tax Rules. 1962. as amended.

6 Retirement Benefits

Gratuity, leave encashment and other retirement benefits, if any, is accounted for as and when paid.

8 Borrowing Costs

Borrowing costs that are attributable to the acquisition or construction of qualifying assets are capitalised as part of the Cost.A qualified asset is one that necessarily takes substantial period of time to get ready for intended use. All other borrowing are charged to Income & Expenditure Account.

7 Provisions and Contingencies

A provision is recognized if, as a result of a past event, the Entity has a present legal obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are determined by the best estimate of the outflow of economic benefits required to settle the obligation at the balance sheet date.

Contingent Liabilities are not provided for and are disclosed by way of Notes on Accounts.

Contingent Assets are neither recognised not disclosed in the Financial statements.

8 Use of Estimates

In preparing the financial statements in conformity with the generally accepted accounting principles, the management is required to make estimates and assumptions that may affect the reported amount of assets and liabilities and disclosure of contingent liabilities as at the date of financial statements and the amount of revenue and expenses during the reported period. Actual results could differ from those estimates. Any revision to such estimates is recognised in the period the same is determined.
